WHEREAS in consideration of the sum of \$ ...... paid by the Member to the Trustee for the Norwood Park Cremation Service Fund established pursuant to an Agreement between Norwood Park Ltd. and Perpetual Trustees as Trustee dated 11<sup>th</sup> July, 1988 (hereinafter called "the Fund"), (the receipt whereof is hereby acknowledged) Norwood Park Pty Ltd. undertakes, covenants and agrees that it will provide upon the death of the member services referred to in the Schedule below, subject to the conditions attached to this Certificate.

All services above shall be provided between the hours of 9.00am and 4.00pm Monday to Friday inclusive, public holidays excepted. If services are required outside these hours an additional fee will be payable.

# CONDITIONS ATTACHING TO CERTIFICATE

- 1. <u>CHANGE OF ADDRESS</u> The address of the member shall be the address stated overleaf or the address last notified to Norwood Park Ltd.. ("Norwood") by the member. It shall be the responsibility of the member at all times to keep Norwood informed of changes of address.
- 2. <u>NOTICE OF DEATH</u> Notice of death of the member is to be given to Norwood as soon as practicable after the death of the member. The certificate must be surrendered to Norwood at its office after the death of the member and prior to the supply of the services thereunder.
- 3. <u>COMPLETION OF APPLICATION AFTER DEATH</u> It shall be a condition of the supply by Norwood of the services that the legal personal representative of the member or his/her next of kin or some other appropriate person shall complete the application for cremation or whatever forms are required by statute or by regulation.
- 4. <u>SERVICES PROVIDED OUTSIDE CERTIFICATE</u> The services to be provided under this certificate shall be as set out in the certificate overleaf. In the event that the legal personal representative or next of kin or some other appropriate person acting in the matter shall request and agree to services other than those set out in the certificate or to services outside the hours and/or area referred to in the certificate an additional fee as prescribed by Norwood at the time of services is required. Such fee shall be payable at the time that application is made. In no circumstances will representatives of a deceased member be required to pay additional charges unless additional services are requested to be rendered or a taxation levy is imposed (see Clause 10).
- 5. <u>OBLIGATIONS OF CERTIFICATE</u> Upon conditions 2 and 3 being complied with, Norwood will perform the obligations imposed by the certificate in accordance with its usual practice, but no responsibility will be accepted by Norwood for any arrangement in connection with the removal of the remains or funeral or cremation or other obligations as aforesaid which may be made with any person or corporation other than Norwood.
- 6. <u>CANCELLATION</u> In the event that this certificate shall become cancelled or surrendered by virtue of the provisions of Statute, or by virtue of a request for withdrawal by the member then the member or the legal personal representative of that member as the case may be, shall be paid the amount held in trust, less administration fees or the amount paid by the member whichever is the lesser upon receiving notice of withdrawal, cancellation or surrender of the Certificate by Norwood.
- 7. <u>WITHDRAWAL</u> A member may at any time withdraw his/her membership and surrender this certificate on giving one month's notice in writing either to the Trustee or to Norwood. The Trustee shall pay to the member the net proceeds of the benefit specified in the life insurance policy (see clause 13) in respect of the member's contribution and such payment shall operate as a complete discharge to Norwood in respect of its obligation to the member for the provision of the cremation services.
- 8. <u>CREMATION FEE AND ADDITIONAL SERVICES</u> In the event of the death of the member in a place more than 200 kilometres from Norwood Park Crematorium, then, provided that prior written arrangements shall have been made by a supplier of funeral or cremation services in that place acceptable to Norwood for provision of the services specified in the certificate overleaf, then Norwood shall pay to that supplier the cost of such services or the amount held in trust less administration fees under the certificate overleaf, whichever shall be the lesser, upon completion of those services, i.e. the services detailed overleaf may be carried out by another, in such event.
- 9. <u>ADDITIONAL CHARGES</u> In the event that State or Federal consumption tax or any similar tax is introduced an additional sum in the form of a taxation levy will be added to the cost of the services and Norwood shall not be obliged to provide any services under this certificate unless such levy has been paid or payment thereof has been secured to its satisfaction.
- 10. <u>ENDORSEMENT</u> No alteration in the terms and/or conditions of this certificate shall be valid unless such alteration shall be endorsed hereon and signed by an officer of Norwood duly authorised to do so, and the member.
- 11. <u>PERSONAL TRANSFER</u> Neither this certificate nor the benefits conferred by it are transferable by the member unless with the written consent of Norwood.
- 12. <u>TRUSTEE</u> All moneys paid to Norwood pursuant to the certificate shall be paid by it to Perpetual Trustees as Trustee to be held in trust for the member for the provision of the services contained herein. The member acknowledges that all amounts paid to Norwood pursuant to the certificate shall be invested by the Trustee in a Life Insurance Policy with Perpetual Trustees. Upon proof of performance of the services the Trustee shall pay to Norwood the amount held by the Trustee in respect of the member.
- 13. <u>CONTRACT</u> This certificate constitutes a contract between Norwood and the member.
- 14. <u>TAX CONSEQUENCES</u> A member in doubt regarding the income tax consequences of withdrawing his/her contribution from the fund should seek professional advice.
